## Programs/Workshops

### April

Our speaker this month is SCQG member, Anne Zick. Anne has been a member of Salt Creek since 1993. She grew up on a farm in Central Illinois, one of 6 children. (Anne has 5 brothers.) Anne was a 4-H member for 10 years and focused on foods and clothing projects. She attended Marycrest College, a girl's school in Davenport Iowa for her first two years of college and completed her college career at the University of Illinois, graduating with a BS in Home Economics. After graduation, she spent 4 years as a Home Economist for the Illinois Power Company in Galesburg, Il. She also worked for the newly organized Environmental Protection Agency in both Washington, D.C. and Chicago before starting her family.



Anne is also a long-time member of the Hinsdale Embroiderers Guild, joining in 1977.

Anne will present a most interesting lecture on Lucy Boston, an amazing 20th century English quilter and author known mostly for her Patchwork of the Crosses quilts.

On Saturday, April 10, Anne will teach an English



Paper Piecing workshop, Patchwork of the Crosses. In the workshop, participants will learn how to use a template to fussy cut different fabrics to make one or several Patchwork of the Crosses used in a pillow or the beginning of a larger wall hanging or quilt. ## May

Programs finishes out the Guild year in May with SCQG member, Lynn Vock. Lynn has been a member of SCQG since 2011 and has taught at various local quilt shops. Lynn will present a trunk show of her work at the May Guild meeting.



On Saturday, May 15, Lynn will teach the workshop, "Knotty Baskets", using the pattern by Auntie Two. Start with 2 1/2 inch strips filled with batting and Craft-tex and weave them to create big, beautiful baskets. Add a row of knots for a unique and unusual embellishment. ## Minutes of February meeting

*Salt Creek Quilt Guild Meeting of March 11, 2021*

The meeting of March 11, 2021 was held via Zoom. Members could socialize starting at 6:30pm. At 7:00pm, the meeting began. There were 52 members present. Motion was made to accept the February meeting minutes as posted in the Patch Dispatch by Linda Kennedy. Motion was seconded by Martha Barry.

Anne Michalik introduced our guest speaker for the night Lori Dickman. Lori resides in Rockford, Illinois. She is an author, pattern maker and award winning quilter. Her lecture was entitled "For the Love of Quilting-Made Easy". Her lecture took us through every aspect of quilting. From organization, thread, bindings, borders, labels, templates and color theory just to name a few. She also showed us her extensive website. Tomorrow she will be teaching her Sunny Dresden quilt.

At 8:15pm Lori's lecture ended and we had Door Prize #1 which was won by Coleen Walter. Show and Tell Part 1 was then shown. Since the response to this month's Show and Tell was so enthusiastic, Kennette split it up into two parts. Part 1 was for non challenge quilts.

Our Business meeting began at 8:30pm. Marilyn stated that donations for our Fabric Donation ends this Sunday. There will be a committee to determine the prize structure for the Fabric Donation Contest. Eight quilts were donated to the Sisters of St. Joseph. We also donated to DePaul.

Publicity. We are developing a list of media contracts. Once Carole King releases her video, Dawn Thanos will release a press release to our media contacts. Marie Dold has agreed to coordinate library displays. We are also trying to offer a virtual beginning quilting class through the libraries. Tomorrow a Google form will be sent out to membership concerning libraries, local media and volunteer opportunities; please fill out and send in.

Nominating Committee. Our Nominating Committee consists of Carol Douglas, Linda Johnson and Lois Dick. The positions they are looking to fill for 2021-2023 guild year are Secretary, Treasurer and VP Contracts/Programs. The April Dispatch will contain the profiles of those nominated. We will have voting of all nominees at our May meeting.

By Law Change. We would like to put before the membership a By Law change. We are looking to implement a position of Assistant President. This member would then move into position of President in her 2nd year of her term. Therefore, we would be nominating an Assistant President every year. Some of the advantages of having an Assistant President and a President are a smooth transition to president, allows for division of responsibilities and

the President will have a back up person. In order to implement this change, we need to have it detailed and posted in the newsletter a month before voting on it. We are hoping to have the written portion in the April Patch Dispatch and vote on it at the May meeting.

Programs. Ann took us through the end of the guild year of programs with a power point presentation. Tomorrow will be the Sunny Dresden workshop. In April we have our own Anne Zick with a presentation on Lucy Boston. Her workshop the following day (April 10, 2021) is a English Paper-Piecing demonstration focusing on Patchwork of the Crosses.

Greg Barner has canceled his May 2021 lecture and class. Our own Lynn Vock will present a trunk show on May 13. On May 15 the workshop will be Knotted Baskets.

## Candidate profiles



### Treasurer

I rejoined SCQG in 2018. I had been a member from 1998-2013. My work schedule changed which caused me to drop out. I would consider myself a modern traditional quilter. My quilts do not always look like the picture. I allow my imagination to take me beyond inspiration the pattern presents. I took my first quilting class in 1981. I made templates out of poster board and cut squares with scissors. Quilting has been the hobby that offered an escape from stresses of working full time and rest of the above.

Why should I be your treasurer? I completed a business degree in 2008. Instead of grad school I chose to enroll in Accounting classes at College of DuPage. Twelve Accounting classes later I was conferred a Certificate in Advanced Accounting. As I was finishing the program the State of Illinois changed the rules for professional Accounting. I have education but not professional Accounting experience. I chose to continue in my career with Navistar Inc as an Engine Engineering Test Technician. I was part of the team responsible for certification testing of our engines. I ran the tests and generated the reports that became legal documents for the EPA and California Air Resource Board. Numbers, documentation, and set procedures kept me laser focused until I retired after 31.5 years in June 2020. During the last ten years at Navistar, I was a Trustee for my bargaining unit UAW 2293. A trustee is tasked with assuring all money and assets are used for legitimate union purposes as authorized by membership. Trustees were responsible for biannual audits.

I will apply my professional work experience to do the job to the best of my abilities.

These changes are deliberately limited to changes required for the addition of the new Vice-President role that was discussed at the March meeting and title changes for other roles to avoid having too many vice-presidents. If this change is approved, we can recruit for the new role over the summer and vote early enough in the guild year to give them most of a year of training and experience.

We have proposed a more complete review of the By-Laws by committee over the summer. If you are interested in joining that committee, please contact Marilyn Montgomery. Any changes suggested through that review would be voted on separately, next year.
